## UNDERSTANDING THE ANC 8(a) SOLE-SOURCE PROCESS

- 1 Agency sends Offer Letter to SBA
- 2 SBA certifies 8(a) eligibility
- 3 SBA sends Acceptance Letter to Agency
- 4 Agency sends RFP/RFQ to 8(a) Company
- 5 8(a) Company responds to RFP/RFQ
- 6 Agency negotiates with Co. & prepares Contract Award
- 7 Award is signed by 8(a) Co. & Agency
- 8 Agency sends a copy to SBA, work begins

### ADDITIONAL CONTRACTING BENEFITS

- DoD can award an 8(a) sole-source contract up to \$100M without Justification and Approval (J&A) (\$25M for civilian agencies)
- ANC 8(a) companies are *not limited* to the traditional \$4.5M sole-source award ceiling
- ANCs are exempt from the total standard 8(a) threshold limit of competitive and direct awards
- ANCs 8(a) awards do not have a total dollar maximum [13 CFR 124.519(a)]
- The sole-source award may not be challenged by another 8(a) participant or any other party, either to the SBA or any other administrative forum as part of a bid or other contract protest
- There is no requirement that a procurement must be competed whenever possible before it can be accepted on a sole-source basis for a tribally-owned or ANC-owned concern [13 CFR 124.517(a)]
